3. Review of Policy and Procedure

Joe D. and Bill P. agreed to collaborate on requesting an informal request for a record of decision to better establish HHHPs identity.

4. Saratoga Surrender Site

A copy of the Saratoga Surrender Site management agreement will be passed to each board member for review at the next meeting. Julie S. asked the board to review the management agreement carefully, as there are questions regarding insurance, general construction management, and NPS's ability to take ownership of the property.

5. Gateway Visitors Center

Joe F. reported that he is working on a change order with the Timber Frame Guild (TFG) for the work this summer. There is a requirement to provide lunch and dinner for about 20 people. Some members of the TFG may want to camp at Fort Hardy Park. Joe F. will work with John S. and the new Mayor to make arrangements.

6. Status of Grants

Joe F. reported that they are still working on the funds from the Canal Corp grant as well as the \$250,000 line item. Jeff C. has also requested a letter from HHHP to see if Senator Marchione can help bring additional funds to the project. Drew A. reported that he contacted the Alfred Z. Solomon Cultural Heritage Trust and received information about how to request and submit an application.

7. History Day at Washington County Fair

Sara I. reported that she had met with Amy B., Brian Mumford, and Marc St. Jacques about organizing a History Day at the Washington County Fair. Sara suggested that it would likely align on Seniors Day. Drew A. reported that he spoke with Pat Niles from Washington County Historical Society who offered to assist with the planning and help reach out to Washington County historical groups.

8. Other Business

Jim B. reported that grant funding for FY17 will soon be available. Grants include: "Making of Nations" interpretive theme grants, Heritage Area Grants, Wayside Exhibit Program, Regional Stakeholder Coordination, Annual International Summit, Passport program and the Mohegan Heritage Trail.

Jim will return in early June for a discussion on programs that we would like CVNHP to consider funding in FY18. Drew A. asked that all ideas be directed to him and he will compile a list.

Drew A. reported that the Friends of Bennington Battlefield passed a resolution pursuant of HHHP membership. The organization will be invited to give a presentation at the next meeting.

Sara I. reported that Greenwich is planning an event at Hudson Crossing Park on June 17 related to their American Battlefield Protection Grant.
